3. Introduction

KSRTC SWIFT Ltd., (A govt. of Kerala Undertaking) operates long distance buses and Electric buses for KSRTC. Presently KSRTC SWIFT Ltd owns 434 buses in which 269 long distance diesel BS6 buses are operating in intercity & interstate routes. These buses are operating an average of 1.0 lakh kms per day. KSRTC SWIFT Ltd. intends to engage an agency for Cleaning & Restoration of used/choked Diesel Particulate Filters of BSVI buses for a period of one year extendable for further one more year based on the evaluation of performance for the successful bidder.

4. Scope of the Contract

E-Tenders are invited for Cleaning & Restoration of used/choked Diesel Particulate Filters of BSVI buses of KSRTC SWIFT Ltd for a period of one year extendable for further one more year based on the evaluation of performance of the successful bidder. (The details of the buses are enclosed in Appendix - I) .

The Deputy General Manager (Technical), KSRTC SWIFT will be the coordinating officer from KSRTC SWIFT Ltd and the contact number is 0471-2993117.

5. PRE -QUALIFICATION CRITERIA

- a. The bidder should be having a DPF restoration facility in India with minimum one year experience in the field.
- b. The bidder should be having a fully fledged office in Kerala.
- c. The bidder should be approved by any Vehicle Manufacturer for the cleaning and restoration of DPF filters.
- d. If the tenderer is a business establishment, it must have a valid registration certificate obtained from the statutory authority
- e. Bidder should have GST Registration.

- f. The bidder should have minimum Average Annual Turnover of Rs.20,00,000/- (Rupees Twenty Lakhs) per year for the last three financial years commencing from 2021-22.

6. General Conditions of the contract

- a. Bidders should remit the required Tender Fee and Earnest Money Deposit (EMD) in Online mode through SBI/NEFT, as per 1(d), 1(e) and I(f) of the Notice Inviting Tender. No exemption in the case of EMD and Tender Fee. Bidders should ensure and convince themselves that the online payments made by them have been successfully transferred. KSRTC SWIFT Ltd. shall under no circumstances be responsible for failed transaction of the payments due to non-compliance of any online banking procedure and consequent rejection of tender.
- d. The tenderer should quote the cost of cleaning & restoration of DPF filter for one bus in each category as Appendix-1 and in BoQ.
- e. Normally the work will be awarded to the tenderer who quotes the lowest amount in tender in each category. The decision of the Chairman & Managing Director on all matters arising out of this Notice / Contract will be final, conclusive and legally binding on all parties concerned.
- f. Opening of E-Tender will be done at the time and date noted in the e- tender portal at the Office of the Chairman and Managing Director, KSRTC.
- g. Firms /Proprietors who have been blacklisted by the Tender inviting Authority/ Central Government/ any State Government /any State Transport Undertaking will be considered disqualified for participating in the tender during the period of blacklisting. An affidavit as per format in Annexure IV (Anti-Blacklisting Affidavit) should be submitted along with the technical bid.

7. MODE OF SUBMITTING TENDERS

1. Tender documents shall be submitted through e-Tender. One for **Pre-Qualification Bid** and the other for **Price Bid**.
2. The tenderer shall submit the tender documents as specified hereunder.
3. The relevant documents to be uploaded shall not be interchanged.

9. TENDER PROCESS:

The tender evaluation will be undertaken in three rounds.

Round 2 Document evaluation.

Round 3 Opening of Price Bid.

1. Round 1- Opening of Pre-Qualification bid documents

The documents uploaded shall be opened at the time and date mentioned.

2. Round 2 Document evaluation:-

The terms and documents submitted as part of the bids shall be scrutinised by the Tender Inviting Authority. The Tender Inviting Authority may call for additional documents/clarifications through e-tender portal. The list of those who come out successfully of the evaluation of the documents as well as

those rejected (with reasons for rejections) will be published on the website of KSRTC (www.keralartc.com), KSRTC SWIFT (www.ksrtcsswift.kerala.gov.in) and objections/remarks against the list will be invited. The objections/ remarks received before the date and time specified in the notice will be considered by the Tender Inviting Authority and the final list of successful bidders of round 2 will be published.

3. Round 3 : Opening of Price Bid.

10. Opening of PRICE BID

- a. The PRICE BID of those bidders, who satisfied all of the Prequalification Criteria, shall only be opened for further consideration. The PRICE BID of those bidders who do not satisfy even any one of the pre-qualification condition will not be opened.
- b. Opening of e-Tender will be done at the time and date noted in the e-Tender portal at the Office of the Chairman and Managing Director, KSRTC.
- c. The bidders have the liberty to resubmit fresh tender/documents till the last date and time of submission of the e-tender.
- d. Resubmission of offer will not be allowed after the time and date fixed for bid submission. The offer once made cannot be withdrawn or modified after the closing of e-tender under any circumstances. Withdrawal or modification of the offer once made in e-Tender will be resulted in the forfeiture of EMD remitted. In such cases the bidder will not have the right to claim the refund of EMD.
- e. The Chairman and Managing Director KSRTC SWIFT Ltd reserve the right to make any modifications or additions in this notice in the event if it is felt that it is in the public interest.

11. GENERAL INSTRUCTIONS TO BIDDERS

- a. Tender shall be made in English.

- h. All uploaded scanned documents should contain the signature and the office seal of the bidders and should be digitally signed while uploading in e-tender portal. Documents uploaded without digitally signing shall entitle rejection of the Tender.
- i. The digitally signed Tender document and other specified documents shall be submitted online through the e-GP website www.etenders.kerala.gov.in well in advance before the last date and time. No submission shall be allowed after the last date mentioned.
- j. Bidders are advised to go through all conditions of the Notice Inviting Tender and the Tender documents carefully and to comply them to avoid rejection of their tender.
- k. Furnishing of any false information / fabricated document would lead to rejection of the tender at any stage.
- l. The bidder shall bear all costs associated with the preparation and submission of its bid and KSRTC SWIFT Ltd, Thiruvananthapuram, hereinafter referred to as Tender Inviting Authority, will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.
- m. Conditional tenders will be summarily rejected.

12. GENERAL TERMS AND CONDITIONS

- a. The Tender Form containing the tender conditions can be downloaded from the e-Tender site. The cost of tender form shall be paid through e-payment. Cost of the tender form is not refundable under any circumstances.
- b. The tenderer should quote the cost of cleaning & restoration of DPF filter for one bus in each category as Appendix-1 and in BoQ.
- c. The work will be confirmed to the Party who quotes the lowest amount in the Tender.
- d. The Company shall normally accept the lowest offer in the tender but the Company reserves the right to accept or reject any of the tenders without assigning any reason whatsoever, if such a step is deemed necessary to safeguard the interest of the Company.

- e. The tenderer should specify in the tender the experience he possesses and the extent of the present business in the relevant field.
- f. The Earnest Money of Rs.20,000/- should be remitted through e- payment in favour of the Financial Advisor & Chief Accounts Officer, Kerala State Road Transport Corporation, Transport Bhavan, Thiruvananthapuram.
- g. If any tenderer withdraws his tender on or after the specified/prescribed time for opening Tender/Auction, the EMD shall be forfeited forthwith. Withdrawal of tender by the successful tenderer will entail forfeiture of EMD without further notice. Moreover, the difference in amount between the highest bidder and the second highest bidder will also be realised from the successful tenderer invoking provisions of Kerala Revenue Recovery Act, 1968 as the case may be. The loss sustained due to the withdrawal of a successful tenderer will be realised from the tenderer in any manner Company may think fit.
- h. The amount remitted as Security Deposit will be released to the party after the satisfactory completion of the contract period without interest.
- i. The successful tenderer shall be required to execute an Agreement (Licence Deed) in stamped paper worth Rs.200/- (Rs. Two Hundred only) as per the draft prescribed by the Company embodying the conditions specified herein and such other terms and conditions as may be decided from time to time if found necessary.
- j. The electoral ID card & Aadhar card number of the licensee and witnesses has to be entered in the agreement and it's self attested copy should be made part of Agreement.
- k. In the case of failure of the successful tenderer to fulfill the conditions herein stated, before the commencement of the contract or to abide by the terms and conditions of the agreement, the Chairman & Managing Director will have the right to cancel the contract and to award the contract to another contractor or to carry out the work by the Company as Company deems it fit and any amount paid by the bidder to the Company will be forfeited. Besides, the successful bidder shall be liable for any loss caused to the Company by reason of cancelling the contract. The amount due to the Company shall be realised under provisions of Revenue Recovery Act as arrears of land revenue or

under the provisions of law in force from any amount due to the licensee on any account or in any other manner as the Company may deem fit.

- l. No representation for the escalation of rates once accepted will be entertained under any circumstances.
- m. The Company shall have the power to cancel the contract entered into with the successful bidder with one-month notice, if it considers that such cancellation is necessary in the interest of the Company / general public. The successful bidder shall abide by such decision of the Company.
- n. The contractor shall be liable to pay taxes or any other amount levied by the Government, local or other authorities from time to time. The contractor shall remit GST if any, along with each payment. If the licensee fails to remit these statutory levies / taxes, the particular amount with interest, penalty imposed by Government / local bodies (i.e. taxes and levies etc.) will be realised from the amount remitted by the contractor towards security deposit. If such liability exceeds the Security Deposit, it will be realised under the provision of Kerala Revenue Recovery Act or any other law then in force in respect of present as well as future claims.
- o. The security amount will be refunded to the contractor after the expiry of the licence period and after the successful completion of the contract period and upon clearance of dues, if any, due to Government or local bodies, as well as after deducting liability if any.
- p. If the contractor retracts from the fulfilment of the contract, he shall be liable to compensate the loss, if any, sustained to Company on account of this. The loss so sustained will be realised from the defaulter invoking provisions of Revenue Recovery act or by invoking provisions of any other law.
- q. The cleaning & restoration of the DPF of BS6 buses are to be in such a manner to remove the accumulated soot and hardened ash.
- r. The cleaning efficiency should be greater than 95% to ensure the performance level greater than 95% compared to a new DPF. The test receipt in this regard of each DPF after the cleaning process to be submitted along with the refurbished DPF.
- s. The preferred cleaning & restoration of DPF using Bio-solvent with pressurised water and air pulse cycles to clean.

- t. Cleaning method involving baking or excessive heating of DPF is not acceptable.
- u. The cleaned DPF should have a service warranty of 3 months or 40,000 kms whichever is earlier.
- v. Any damages occurred to the DPF while restoration will be the responsibility of the contractor and any loss on account of this will be recovered from the contractor.
- w. The contractor has to collect the DPF for restoration from the location as intimated by KSRTC/ KSRTC SWIFT Ltd and the same has to be delivered within 48 hrs, from the time of intimation, to the same location after restoration. Any delay for delivery will be treated as revenue loss to the company and will be recovered from contractor.
- x. List of buses and respective depots will be provided before the execution of agreement.
- y. The contractor has to submit the invoice, for the approved amount for the respective category of bus, along with the restored DPF to the concerned depot/location.
- z. The payment for the contractor will be processed monthly after the receipt of satisfactory confirmation from the respective depot(s).
- aa. The payment in respect of the restoration charges will be paid on or before the 10th working day of the successive month.
- bb. The Chairman & Managing Director, KSRTC SWIFT Ltd., has the right to impose penalty / fine, if any, for the violation of any of the conditions mentioned herein.
- cc. Grievances, complaints shall be entertained within 30 days only. Any requests received after 30 days time shall be rejected.
- dd. If the successful tenderer fails to execute the agreement as instructed in the provisional confirmation order, the Company will be at the liberty to confirm the tender in favour of the second lowest bidder, if it deems fit and loss on account of this (i.e. difference between the highest and second highest bid amount) will be realised from the defaulted tenderer by invoking provision of Kerala Revenue Recovery Act or any other law then in force.

ee. Neither KSRTC SWIFT Ltd nor contractor shall be liable for any inability to fulfil their commitments and obligations hereunder occasioned in whole or in part by Force Majeure, any of the following events resulting in material adverse effect, shall constitute force majeure events:

- Earthquake, Flood, Inundation, Landslide.
- Storm, Tempest, Hurricane, Cyclone, Lighting, Thunder or other extreme atmospheric Disturbances.
- Fire caused by reasons not attributable to the Licensor. Acts of terrorism.
- War, hostilities (whether war be declared or not), invasion, act of foreign enemy, rebellion, riots, weapon conflict or military action or civil war.
- Strikes or boycotts, other than those involving the Licensor, its contractors, or their employees, agents etc, and
- Any other similar things beyond the control of the party, except court order/ court judgment.
