1. TECHNICAL & COMMERCIAL BID

2. Introduction

KSRTC SWIFT Ltd., (A govt. of Kerala Undertaking) operates long distance buses and Electric buses for KSRTC. Presently KSRTC SWIFT Ltd owns 434 buses in which 269 long distance diesel BS6 buses are operating in intercity & interstate routes. These buses are operating an average of 1.0 lakh kms per day. KSRTC SWIFT Ltd. intends to engage an agency for Cleaning & Restoration of used/choked Diesel Particulate Filters of BSVI buses for a period of one year extendable for further one more year based on the evaluation of performance for the successful bidder.

3. Scope of the Contract

E-Tenders are invited for Cleaning & Restoration of used/choked Diesel Particulate Filters of BSVI buses of KSRTC SWIFT Ltd for a period of one year extendable for further one more year based on the evaluation of performance of the successful bidder. (The details of the buses are enclosed in Appendix - I).

The Deputy General Manager (Technical), KSRTC SWIFT will be the coordinating officer from KSRTC SWIFT Ltd and the contact number is 0471-2993117.

4. PRE QUALIFICATION CRITERIA

- i. The bidder should be having a DPF restoration facility in India with minimum one year experience in the field.
- ii. The bidder should be having a fully fledged office in Kerala.
- iii. The bidder should be approved by any Vehicle Manufacturer for the cleaning and restoration of DPF filters.
- iv. If the tenderer is a business establishment, it must have a valid registration certificate obtained from the statutory authority
- v. Bidder should have GST Registration.
- vi. The bidder should have minimum Average Annual Turnover of Rs.20,00,000/- (Rupees Twenty Lakhs) per year for the last three financial years commencing from 2021-22.

5. General Conditions of the contract

i. Bidders should remit the required Tender Fee and Earnest Money Deposit (EMD) in Online mode through SBI/NEFT, as per 1(d), 1(e) and I(f) of

the Notice Inviting Tender. No exemption in the case of EMD and Tender Fee. Bidders should ensure and convince themselves that the online payments made by them have been successfully transferred. KSRTC SWIFT Ltd. shall under no circumstances be responsible for failed transaction of the payments due to non-compliance of any online banking procedure and consequent rejection of tender.

- ii. The tenderer should quote the cost of cleaning & restoration of DPF filter for one bus in each category as Appendix-1 and in BoQ.
- iii. Normally the work will be awarded to the tenderer who quotes the lowest amount in tender in each category. The decision of the Chairman & Managing Director on all matters arising out of this Notice / Contract will be final, conclusive and legally binding on all parties concerned.
- iv. Opening of E-Tender will be done at the time and date noted in the etender portal at the Office of the Chairman and Managing Director, KSRTC.
- v. Firms /Proprietors who have been blacklisted by the Tender inviting Authority/ Central Government/ any State Government /any State Transport Undertaking will be considered disqualified for participating in the tender during the period of blacklisting. An affidavit as per format in Annexure IV (Anti-Blacklisting Affidavit) should be submitted along with the technical bid.
- vi. The cleaning & restoration of the DPF of BS6 buses are to be in such a manner to remove the accumulated soot and hardened ash.
- vii.The cleaning efficiency should be greater than 95% to ensure the performance level greater than 95% compared to a new DPF. The test receipt in this regard of each DPF after the cleaning process to be submitted along with the refurbished DPF.
- viii. The preferred cleaning & restoration of DPF using Bio-solvent with pressurised water and air pulse cycles to clean.
- ix. Cleaning method involving baking or excessive heating of DPF is not acceptable.
- x. The cleaned DPF should have a service warranty of 3 months or 40,000 kms whichever is earlier any defects /failure due to poor quality of cleaning, and not due to failure of any other related components. However the cleaned DPF filter shall not effect normal functioning of other components in the system.
- xi. Any damages occurred to the DPF while restoration will be the

responsibility of the contractor and any loss on account of this will be recovered from the contractor. The contractor shall have to inspect the filters for any damages and those not suitable for repairs shall be rejected to avoid rejection after cleaning as far.

- xii.The contractor has to collect the DPF for restoration from the location as intimated by KSRTC/ KSRTC-SWIFT Ltd and the same has to be delivered at the earliest as far as possible however shall not exceed 4 days, from the time of intimation, to the same location after restoration. Any delay for delivery will be treated as revenue loss to the company and will be recovered from contractor.
- xiii. List of buses and respective depots will be provided before the execution of agreement.
- xiv. The contractor has to submit the invoice, for the approved amount for the respective category of bus, along with the restored DPF to the concerned depot/location.
- xv.The payment for the contractor will be processed monthly after the receipt of satisfactory confirmation from the respective depot(s).
- xvi. The payment in respect of the restoration charges will be paid on or before the 10th working day of the successive month.

6. Documents to be uploaded in the e-tender Portal

- i. All pages of NIT, Appendix and Annexures duly signed and stamped by the bidder.
- ii. General information about the Tenderer (Annexure I) duly filled and signed by the tenderer
- iii. Annual Turnover Statement (Annexure II) duly filled and signed by the Auditor.
- iv.Format for Affidavit certifying that Entity / Promoter(s) / Director(s)/Partners of Entity are not blacklisted / Defaulter /Involved in litigations (Annexure-III).
- v. Include authoritative documental proof of Firms/ Proprietorship/ Company/Individual.
- vi. Authorization Certificate to participate in the tender as per Annexure IV, wherever applicable.
- vii. Details of experience, in the respective field.

7. Instructions for submitting Financial bid :-

- a. The bidder should furnish the basic rate for the Cleaning and Restoration of used/choked Diesel Particulate Filters for one bus, discount, GST separately. The rates shall be submitted in BOQ portion of the corresponding Tender published in website www.etenders.kerala.gov.in
- b. GST should be calculated exactly and entered in the respective column of BOQ. In the BOQ the GST is to be mentioned in rupees, not in %, therefore bidders are requested to upload the rate accordingly.
- c. If the amount of GST is not entered in the respective column of BOQ, such bidders will not be eligible for revised levies declared from time to time.
- d. The quantity of item may increase or decrease. The tolerance limit shall not be more than plus / minus fifteen percent (\pm 15%) as per the provisions of Kerala Store Purchase Manual.

8. TENDER PROCESS:

The tender evaluation will be undertaken in four rounds.

Round 1- Opening of technical bid documents

Round 2 – Document evaluation.

Round 3 – Opening of Price Bid.

a. Round 1- Opening of technical bid documents

The documents uploaded shall be opened at the time and date mentioned. The prospective bidders or their authorized representatives can present, if required by them.

b. Round 2 – Document evaluation:- The format for submission of the technical bid as per annexures and submission in any other format or absence of requisite information will lead to rejection of bids in the round 2 evaluation itself. The prospective bidders are advised to submit all information and supporting documents that are required to prove their competency and claims for technical evaluation.

The commercial terms and documents submitted as part of the bids shall be scrutinized by a Bid Evaluation Committee constituted by the Tender Inviting Authority.

The Tender Inviting Authority may call for additional documents/clarifications through e-tender portal.

The list of those who come out of the evaluation of the documents successfully as well as those rejected (with reasons for rejections) will be published on the website of KSRTC and KSRTC - SWIFT (www.keralartc.com) and objections/remarks against the list will be invited. The objections /remarks received before the date and time specified in the notice will be considered by the Tender Inviting Authority and the final list of successful bidders of round 2 will be published.

c. Round 3 - Opening of Price Bid.

The bidders who are qualified in round 2 shall be considered for Round -3. The BOQ/PRICE BID of those bidders who do not satisfy even any one of the pre-qualification condition will not be opened.

9. General and Procedural Clauses

a. Performance Security

The successful bidder shall submit a performance security of Rs.1,00,000/- in the form of DD/Bank Guarantee within 15 days of issuance of the Letter of Award. The security deposit will be released four (4) months after contract completion, subject to clearance of all dues.

b. Force Majeure

In the event of a force majeure situation, the affected party shall notify the other in writing within seven (7) days of the occurrence, specifying the nature and anticipated duration of the event

c. <u>Subcontracting</u>

Subcontracting of any portion of the contract is not permitted without prior written approval from KSRTC-SWIFT Ltd.

d. Termination for Convenience

KSRTC-SWIFT Ltd reserves the right to terminate the contract at any time by giving one (1) month's notice in writing. The vendor may also terminate the contract with one (1) month's notice, subject to settlement of all dues and penalties.

e. Dispute Resolution

All disputes arising out of this contract shall be subject to the jurisdiction of courts at Thiruvananthapuram, Kerala

10.Liquidated damages for non supply and performance:- The successful bidder shall arrange installation of WiFi facility in buses as per the delivery schedule given by KSRTC – SWIFT Ltd. If not provided WiFi facility in bus as per supply schedule given by KSRTC – SWIFT Ltd, liquidated damages will be realised from the contractor at the rate of 0.5% of the Cost of item per week for each week or part there of, up to a maximum deduction of 10% of the Contract prices and there after the Corporation will consider the termination of the contract at the risk and cost of the contractor.

- 11.<u>Earnest Money Deposit</u>:- The EMD will not carry any interest. The EMD will be forfeited, if the successful Bidders fail to execute agreement and furnish Security deposit, or in the event of withdrawal of offer once made or in the event of putting forth any conditions which are against or contradictory to the conditions of this Notice Inviting Tender.
- 12.Opening of E-Tender will be done at the time and date noted in the e- tender portal at the Office of the Chairman and Managing Director, KSRTC SWIFT Ltd.
- 13.The bidders have the liberty to resubmit fresh tender/documents till the last date and time of submission of the e-tender.
- 14.Resubmission of offer will not be allowed after the time and date fixed for bid submission. The offer once made cannot be withdrawn or modified after the closing of e-tender under any circumstances. Withdrawal or modification of the offer once made in e-Tender will be resulted in the forfeiture of EMD remitted. In such cases the bidder will not have the right to claim the refund of EMD.
- 15.The Chairman and Managing Director KSRTC SWIFT Ltd reserve the right to make any modifications or additions in this notice in the event if it is felt that it is in the public interest.

16. GENERAL TERMS AND CONDITIONS

- a. The work will be confirmed to the Party who quotes the lowest amount in the Tender.
- b. The Company shall normally accept the lowest offer in the tender but the Company reserves the right to accept or reject any of the tenders without assigning any reason whatsoever, if such a step is deemed necessary to safeguard the interest of the Company.
- c. The tenderer should specify in the tender the experience he possesses and the extent of the present business in the relevant field.
- d. If any tenderer withdraws his tender on or after the specified/prescribed time for opening Tender/Auction, the EMD shall be forfeited forthwith. Withdrawal of tender by the successful tenderer will entail forfeiture of EMD without further notice. Moreover, the difference in amount between the highest bidder and the second highest bidder will also be realised from the successful tenderer invoking provisions of Kerala Revenue Recovery

Act, 1968 as the case may be. The loss sustained due to the withdrawal of a successful tenderer will be realised from the tenderer in any manner Company may think fit.

- e. There shall be a security deposit of Rs.1,00,000/- in the form of DD/Bank guarantee, which shall be submitted by the successful tenderer. The performance security shall be released on 4 months after completion of contract period on clearing of dues to the company if any. There shall not be any interest on security deposit.
- f. The successful tenderer shall be required to execute an Agreement (Licence Deed) in stamped paper worth Rs.200/- (Rs. Two Hundred only) as per thedraft prescribed by the Company embodying the conditions specifiedherein and such other terms and conditions as may be decided from time totime if found necessary.
- g. The electoral ID card & Aadhar card number of the licensee and witnesses has to be entered in the agreement and it's self attested copy should be made part of Agreement.
- h. In the case of failure of the successful tenderer to fulfil the conditionsherein stated, before the commencement of the contract or to abide by the terms and conditions of the agreement, the Chairman & Managing Director will have the right to cancel the contract and to award the contract to another contractor or to carry out the work by the Company as Company deems it fit and any amount paid by the bidder to the Company will be forfeited. Besides, the successful bidder shall be liable for any loss caused to the Company by reason of cancelling the contract. The amount due to the Company shall be realised under provisions of Revenue Recovery Act as arrears of land revenue or under the provisions of law in force from any amount due to the licensee on any account or in any other manner as the Company may deem fit.
- i. No representation for the escalation of rates once accepted will be entertained under any circumstances.
- j. The Company shall have the power to cancel the contract entered into with the successful bidder with one-month notice, if it considers that such cancellation is necessary in the interest of the Company / general public. The successful bidder shall abide by such decision of the Company.
- k. The contractor shall be liable to pay taxes or any other amount levied by the Government, local or other authorities from time to time. The contractor shall remit GST if any, along with each payment. If the

licensee fails to remit these statutory levies / taxes, the particular amount with interest, penalty imposed byGovernment / local bodies (i.e. taxes and levies etc.) will be realised from the amount remitted by the contractor towards security deposit. If such liability exceeds the Security Deposit, it will be realised under the provision of Kerala Revenue Recovery Act or any other law then in force in respect of present as well as future claims.

- The security amount will be refunded to the contractor after the expiry of the licence period and after the successful completion of the contract period and upon clearance of dues, if any, due to Government or local bodies, as well as after deducting liability if any.
- m. If the contractor retracts from the fulfilment of the contract, he shall be liable to compensate the loss, if any, sustained to Company on account of this. The loss so sustained will be realised from the defaulter invoking provisions of Revenue Recovery act or by invoking provisions of any other law.
- n. Any damages occurred to the buses, parts, wiring and battery while or due to installation, commissioning or maintenance of Wi-Fi facilities will be the responsibility of the contractor and any loss on account of this will be recovered from the contractor.
- o. The contractor has to install, commission or maintenance the Wi-Fi from the location as intimated by KSRTC/ KSRTC SWIFT Ltd that is at KSRTC Depots in Kerala, when the buses are available. Any delay for delivery will be treated as revenue loss to the company and will be recovered from contractor.
- p. List of buses and respective depots will be provided before the execution of agreement.
- q. The contractor has to submit the original invoice, for the approved amount for the respective category of bus, installation certificate of the contractor along with the copy of Goods Received (GR) Note by the Unit officer concerned, KSRTC to the General Manager, KSRTC SWIFT Ltd.
- r. The payment for the contractor will be processed monthly after the receipt of the original Goods Received (GR) Notes and satisfactory confirmation from the respective depot(s).
- s. The payment in respect of the installation charges will be paid on or before the 10th working day of the successive month.

- t. The Chairman & Managing Director, KSRTC SWIFT Ltd., has the right to impose penalty / fine, if any, for the violation of any of the conditions mentioned herein.
- u. Grievances, complaints shall be entertained within 30 days only. Any requests received after 30 days time shall be rejected.
- v. If the successful tenderer fails to execute the agreement as instructed in the provisional confirmation order, the Company will be at the liberty to confirm the tender in favour of the second lowest bidder, if it deems fit and loss on account of this (i.e. difference between the highest and second highest bid amount) will be realised from the defaulted tenderer by invoking provision of Kerala Revenue Recovery Act or any other law then in force.
- w. Neither KSRTC SWIFT Ltd nor contractor shall be liable for any inability to fulfil their commitments and obligations hereunder occasioned in whole or in part by Force Majeure, any of the following events resulting in material adverse effect, shall constitute force majeure events:
- Earthquake, Flood, Inundation, Landslide.
- Storm, Tempest, Hurricane, Cyclone, Lighting, Thunder or other extreme atmospheric Disturbances.
- Fire caused by reasons not attributable to the Licensor. Acts of terrorism.
- War, hostilities (whether war be declared or not), invasion, act of foreign enemy, rebellion, riots, weapon conflict or military action or civil war.
- Strikes or boycotts, other than those involving the Licensor, its contractors, or their employees, agents etc, and
- Any other similar things beyond the control of the party, except court order/ court judgment.
- x. Any dispute/complaint arising out of this tender will be addressed in writing to the General Manager (KSRTC – SWIFT Ltd). The decision of the Chairman & Managing Director on all matters arising out of the agreement will be final, conclusive and legally binding on all parties concerned. The Chairman & Managing Director reserves the right to cancel the tender without showing any reason.
- y. Disputes if any, arising out of this agreement shall be settled within the jurisdiction of Courts at Thiruvananthapuram.
