Anayara, Thiruvananthapuram, before **13.00 hrs on 23/09/2025.** The tenders will be opened at 15:00 hrs on the same day in the presence of tenderers or their authorized representatives who may be present at that time. **There shall not be more than one financial offer in a financial bid for one item. Offering more than one brand / model will make the bid invalid.**

1. The rates quoted should be inclusive of all taxes, duties, freight charges etc., for the Door delivery at KSRTC SWIFT, Anayara, Thiruvananthapuram.
2. An EMD of Rs 5,000/- in the form of Demand Draft drawn in favour of Chairman and Managing Director, KSRTC SWIFT Ltd. shall be submitted along with the tender offer.

3. **The tender should contain the make, brand and name of manufactures, if any. There shall not be more than one brand offer.**
4. Payment will be made within one month after supply as per specification and acceptance of the materials at the destination specified in the purchase order.
5. Tender will be opened at **15.00 hrs** on **23/09/2025** in the presence of the tenderers or their authorized nominees available at the time of opening.
6. The bidder shall submit one sample of the item as and when instructed by this office.
7. The Successful tenderer has to execute an agreement as per the provisions of Kerala Store Purchase rules after furnishing a security deposit equal to the 5% of the total cost of the materials ordered for the due fulfillment of the contract. The Security Deposit will be refunded only after the successful completion of the contract. **No interest will be paid for Security Deposit.**
8. **The L1 bidder shall provide one bed cover as per the approved sample. Bulk orders will be placed only upon approval of the sample. If the sample is not approved, the offer will be rejected.**
9. **The bidder must possess valid GST registration.**
10. The supply of materials shall be completed within **10 days** from the date of confirmation of order. In case of failure, the Company reserves the right to procure the materials from other sources at the risk and cost of the tenderer.
11. No enhancement of rates, once accepted, will be considered.
12. The tenderer shall clearly specify the delivery position in the tender.
13. Items not meeting the required quality standards shall be rejected without any cost to the Company.
14. The quantity may vary by up to 30% depending on requirements. The contract will be valid for **one year**, during which no price increase will be allowed
15. The tender should be submitted in sealed covers, duly superscribed with the following details, so as to reach this office **on or before 13:00 hrs on 23/09/2025. Late tenders will not be accepted.**
